#### How we collect and use (process) your personal information

Vals AI, Inc. collects personal information about its website customers. With a few exceptions, this information is generally limited to:

- name
- job title
- employer name
- work email

We use this information to provide prospects and customers with services. We do not sell personal information to anyone and only share it with third parties who are facilitating the delivery of our services.

Depending on the circumstance, Vals AI, Inc. also collects and transfers to the U.S. personal data with consent; to perform a contract with you; or to fulfill a compelling legitimate interest of Vals AI, Inc. in a manner that does not outweigh your rights and freedoms. Vals AI, Inc. endeavors to apply suitable safeguards to protect the privacy and security of your personal data and to use it only consistent with your relationship with Vals AI, Inc. and the practices described in this Privacy Statement. Vals AI, Inc. also enters into data processing agreements and model clauses with its vendors whenever feasible and appropriate. Since it was founded, Vals AI, Inc. has received zero government requests for information.

# Data Subject rights
